### **Dear Parents**

As you will no doubt appreciate, Government funding for schools is under pressure, reducing the amount of money available to improve the school's facilities for the children and limiting our ability to enrich their educational experience. More than ever, we are relying heavily on the generous voluntary donations that parents contribute to the School Fund, to maintain our creative curriculum and to improve our school facilities.

#### How much is School Fund and how will it be spent?

The annual contribution is determined by the Governing Body and for 2021/22 the suggested amount of voluntary contribution is £100 a year or £10.00 per family per month. We fully understand that not everyone will be able to contribute at this level but are grateful for any donations you are able to make.

School Fund is used for a variety of purposes but the general principle is that it must be used for the benefit of all the children in the school. School Fund often donates funds to larger projects; recently contributing to our woodland themed library and improving our outdoor spaces including the lower playground and outside the KS1 and KS2 classrooms. In addition, it contributed to the acquisition of new iPads, which children continue to use to support their learning. Every year it provides funding for extra-curricular activities and helps to subsidise the cost of several educational visits for all children.

## How can we pay the contributions?

There are different ways for you to contribute: you may choose to make a one-off payment or to spread the cost throughout the year with a regular standing order. As a cashless school, electronic payments will significantly reduce our administrative burden so we ask that you use these options wherever possible.

You can donate online via your ParentMail account or via the ParentMail App on your mobile phone – look for School Fund 2021/22 in the Shop. If you use online banking you can set up a standing order or transfer funds directly into the School Fund account (details below). Please give your child / children's name as a reference. Alternatively, the provided form can be returned with a cheque to the school.

#### What is so important about Gift Aid?

The school is a registered charity and is therefore eligible to reclaim from HMRC. If you are a UK taxpayer please 'Gift Aid' your donation because for every £1 you donate, we can claim a further 25p from HMRC with no cost to you. For every donation of £100 this means a further £25 for the School. Almost everyone who pays UK tax can 'Gift Aid' their donation, and you can do so by
